Message from the Independent Chair and Scrutineer - Brian Boxall

The Safeguarding Board has published its first allage <u>Annual Report for 2019-20</u>. It describes the implementation of the new multi-agency safeguarding arrangements, progress to date and the contribution of the wide range of partners who are members of the Safeguarding Partnership that supports the work of the Board.

The Safeguarding Board and Partnership have been responsive to the changing circumstances throughout the pandemic with the Board now meeting every three months and Partnership every six weeks.

The Board continues to undertake adult and children case reviews; Child J being the most recent. This review is especially impactive as it has been informed by Child J whose insight is very thought provoking. These reviews are good opportunities to review how the safeguarding system works and is producing important lessons. It is important that the learning is shared and to that end there will be a webinar with the author of Child J review on 2nd December 2020. Details of this and other learning and training events are set out in this bulletin.

The Partnership continues to look at how we can hear the voices of the child and adult. The Partnership heard from the Young Health Champions across East Berkshire who are an inspirational group of young people who work with and support young people and provide them with a voice. COVID 19 continues to have a significant impact on the lives of everyone, including the work of partners and their staff. At the recent Safeguarding Partnership meeting, Healthwatch highlighted the concerns they have around unpaid carers being very isolated with little respite and the potential this has for adversely impacting on their mental and physical health. The Community Response hub continues to deal with residents' concerns and where necessary signpost to other organisations with volunteers also identifying and reporting safeguarding issues. The Communications, Engagement and Prevention (CEP) subgroup are supporting the roll out the Making Every Contact Counts (MECC) approach and are asking partners to implement MECC and promote the training resources within their organisations. This approach is intended to provide staff with tools that will encourage them to talk to the public about their health and wellbeing to help individuals and communities significantly reduce their risk of disease (and factors relating to safeguarding such as use of alcohol and mental ill-health). Public health staff will contact each organisation, on behalf of the CEP group, to carry out a short evaluation of the use of MECC during late spring / early summer.

I hope that the information in this newsletter continues to help support you in your work. Please ensure that you circulate it as widely as possible.

Key Workers Can Help Spot Abuse During Coronavirus Pandemic



Abuse during the Coronavirus Pandemic

As key workers on the frontline during this crisis, you are not only providing a critical service to the country to ensure our safety, but you may also be the only other people that victims of abuse have interactions with outside of their home.

This means you are in a unique position to help those suffering from abuse, and potentially save lives.

Here are some signs that you can be on the lookout for, and you may find that the signs build up the more you see an individual:

- Physical injuries
- Clothing worn or heavy make-up to cover injuries
- Appearing afraid or anxious to please their partner
- Checking in with their partner to report where they are
- Not having their own access to money
- Being withdrawn and unwilling to engage in conversation
- Presenting as meek, fearful or extremely apologetic
- Shouting and screaming regularly heard from the same homes

This may be a family in crisis that needs help now. If the abuse is happening now and they are at risk right now, call 999. Alternatively call 101 and report it, or via Crimestoppers confidentially. Alternative routes to report include the NSPCC and Victims First.

'Wednesday Wave' for people who are lonely

Thames Valley Police are warning of a potential exploitation risk with a new national initiative running until 16 December called the Wednesday Wave. The idea is to tackle loneliness and isolation by encouraging vulnerable and lonely people to print a poster and put it on their window, visible from the

street. This tells everyone walking past that they are lonely, and people are encouraged (given permission by the poster) to wave at them. A lovely idea but perhaps not well thought through in terms of highlighting to potential offenders that this person is vulnerable and may therefore have negative consequences.

Ofsted head warns of rise in harm to babies during lockdown

Ofsted chief inspector Amanda Spielman has said that there was a 20% rise in the number of babies killed or harmed between April and October, as social workers faced difficulties making home visits due to coronavirus restrictions. Ms Spielman has urged local authorities to be "alive to this hidden danger," and to ensure that all



vulnerable young children are protected as issues like financial hardship, loss of employment, isolation and close family proximity put "extra pressure on families that were already struggling." Cllr Judith Blake, chair of the Local Government Association's children and young people board, says councils have "worked tirelessly" to keep children safe during recent months, and that it is "absolutely critical that professionals are able to keep engaging with families throughout any restrictions, whether local or national."

Working closely with the Berkshire Child Death Overview Panel we'd like to remind colleagues of some important messages based on our local learning. The Safeguarding Board have webpages designed to highlight risks and provide <u>support in respect of babies and toddlers</u>.



Ofsted: Children hardest hit by COVID

Ofsted published its <u>second report</u> on the effect of Covid-19 across its sectors. It continues to be worried about the children who were out of sight during the closure of schools. Referrals to social care teams have fallen and have not

returned to more typical levels since schools have reopened. This raises concerns that domestic neglect, exploitation or abuse is going undetected. Their October briefing notes (which include education, SEND & social care) are available <u>here.</u>


